- In Federal Circuit Court, obtained a ruling that reversed the district court's judgment of infringement on behalf of an international manufacturer of mining equipment. The court held, in *Gillespie v. Dywidag Systems International, USA*^{*}, that under a proper claim construction our client's mine-roof-bolt product did not infringe.
